CONSENT ORDER

By letter dated October 17, 2006, the Virginia Board of Veterinary Medicine ("Board") noticed Dr. Manning for an informal conference to inquire into allegations that he may have violated certain

laws and regulations governing the practice of veterinary medicine in the Commonwealth of Virginia.

Now come the Virginia Board of Veterinary Medicine ("Board") and Thomas O. Manning, D.V.M., and as evidenced by their signatures affixed below, enter into this Consent Order affecting the

license of Dr. Manning to practice veterinary medicine in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW.

1. Thomas O. Manning, D.V.M., holds license number 0301-200165 issued by the Board to

practice veterinary medicine in the Commonwealth of Virginia.

2. Dr. Manning is in violation of § 54.1-3807 (5) and (6) of the Code, and 18 VAC 150-

20-140 (6) and (7) of the Regulations of the Board of Veterinary Medicine as more fully set out in

Attachment A.

CONSENT

Thomas O. Manning, D.V.M., by affixing his signature hereon, agrees to the following:

1. He has been advised specifically to seek the advice of counsel prior to signing this

document:

2. He is fully aware that without his consent, no legal action can be taken against him

except pursuant to the Virginia Administrative Process Act, §2.2-4000A et seq. of the Code;

- 3. He has the following rights, among others:
 - a. the right to informal conference before the Board; and
 - b. the right to appear in person or by counsel, or other qualified representative before the agency;
- 4. He waives all rights to an informal hearing;
- 5. He admits the truth of the above Findings of Fact; and
- 6. He consents to the following Order affecting his license to practice veterinary medicine in the Commonwealth of Virginia.

ORDER

WHEREFORE, on the basis of the foregoing Findings of Fact, Conclusions of Law, and with the consent of the licensee, it is hereby ORDERED that in lieu of convening an administrative proceeding against the license of Thomas O. Manning, D.V.M., Dr. Manning shall SURRENDER his license to the Board with the return of this signed Consent Order. Upon the receipt of this Consent Order, the Board shall ACCEPT the SURRENDER of the license of Dr. Manning. The license will be recorded as SURRENDERED.

Should Dr. Manning seek to have his license reinstated, he must submit the appropriate application and associated fees to the Board and petition to be heard before an informal conference. Dr. Manning has the burden of proof that he is safe and competent to practice veterinary medicine in the Commonwealth of Virginia.

Pursuant to Sections 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Consent Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public release, inspection and copying upon request.
